You will be asked to provide information regarding your financial circumstances and the nature of your legal concern when you contact any of these programs. The information you provide allows each program to help determine if you are eligible for their services.

Legal information and referral services are provided to any resident of Lancaster County who is 60 years of age or older. These services are funded by the City of Lincoln and Lancaster County, and are provided without cost to you. Representation in some matters may also be provided without cost if you are within certain income and resource guidelines.

Monthly gross income guidelines:

One person: \$1,300
Two people: \$1,750

Resources:

Less than \$10,000 in liquid resources (excluding principal residence).

Free legal representation is provided in certain types of civil legal cases only by certified senior law students. Individuals qualify for services by being within the following financial guidelines:

Monthly gross income guidelines:

One person: \$1,084
Two people: \$1,459

Resources:

Generally \$5,000 maximum cash resources per individual; some exceptions apply.

There is a one time \$15.00 administrative fee charged to each individual case.

Counties covered by the program are Butler, Fillmore, Lancaster, Polk, Saline, Saunders, Seward, and York.

The Civil Clinical Law Program is closed during the winter class break (generally from Christmas through the new year).

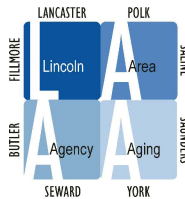
